

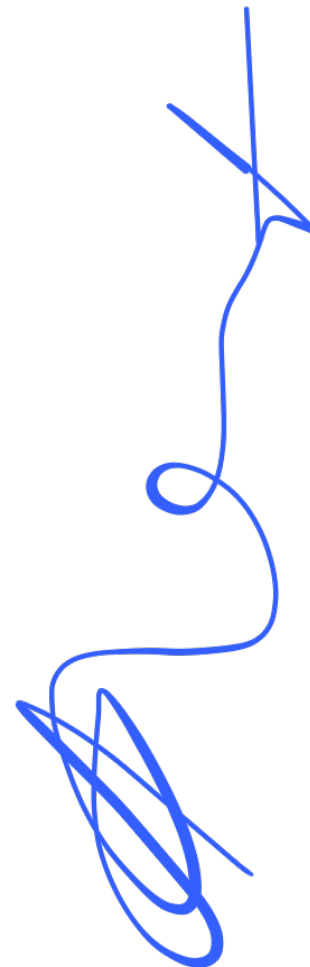

4.	An Authority Letter addressed to the Airline on which you have travelled or will be travelling. This essentially is a request for a Departure Certificate from the Airline and is mandated by Indian Customs as a part of the customs documentation to be submitted
5.	A set of Customs Invoice and Customs Packing List in duplicate which only requires your signature, list of articles and values will be completed by us upon completion of the packing of your effects
6.	Destination data sheet
7.	Insurance value declaration list – (suggest to provide replacement cost) for transit insurance.
8.	Few signatures in the dox we provide related to EXPORT.
9.	If applicable, Client to Apply TOR directly to obtain duty concession.
10.	OCI Card / PIO card / Residence permit copy / FRRO in case of foreign passport holder (whichever is applicable in your case)
